**ORDER CONTINUING HEARING ON REPORT AND
PETITION TO BORROW FUNDS AND TO LEVY ASSESSMENTS
AND SECOND NOTICE OF HEARING**

THE ABOVE MATTER COMING ON FOR HEARING on the 20th day of August, 2018, on the Report and Petition of the Heart Mountain Irrigation District to Borrow Funds and to Levy Assessments, pursuant to the Notice of Hearing filed July 18, 2018. The Court having determined that additional time is necessary to hear any objections, finds that a continuance of the hearing is necessary;

All objections must be filed in writing with the Clerk of the District Court no later than three (3) business days prior to the hearing date and provide a copy to Mary
